In accordance with the Regulations, the Company has proposed to issue 50,00,000 (Fifty Lakhs only) warrants, each convertible into, or exchangeable for, 1 (One) fully paid-up equity share of the Company of face value ₹10.00/- (Rupees Ten only) ("**Warrants**"), at a price of ₹56.20/- (Rupees Fifty Six and Twenty Paise Only) each (including the warrant subscription price and the warrant exercise price) payable in cash ("**Warrant Issue Price**") aggregating upto ₹28,10,00,000/- (Rupees Twenty Eight Crore Ten Lakhs Only) ("**Total Issue Size**") to persons / entity enlisted below ("**Warrant Holder**" / "**Proposed Allottees**") belonging to non-promoter group of the Company on a preferential basis ("**Proposed Preferential Issue**"). The proposed preferential issue was approved at the meeting of Board of Directors of the Company held on April 29, 2024.

On the basis of the relevant management inquiries, necessary representations and information received from/furnished by the management of the Company, as required under the aforesaid Regulations, I have verified that the issue is being made in accordance with the requirements of these Regulations as applicable to the preferential issue, more specifically, the following:

- vi. All equity shares held by the proposed allottees in the Company are in dematerialised form.
- vii. Details of buying, selling and dealing in the equity shares of the Company by the proposed allottees during the 90 trading days preceding the relevant date;
- viii. Permanent Account Numbers of the proposed allottees;
- ix. Draft notice of General Meeting including the disclosure in Explanatory Statement as required under Companies Act, 2013 & the Companies (Share Capital and Debentures) Rules, 2014 and Regulation 163(1) of the Regulations.
- x. Valuation Report of Independent Registered Valuer for pricing of frequently traded shares;
- xi. Verified the relevant statutory records of the company to confirm that:
  - a. it has no outstanding dues to the SEBI, the stock exchanges or the depositories except those whose are the subject matter of a pending appeal or proceeding(s), which has been admitted by the relevant Court, Tribunal or Authority.
  - b. it is in compliance with the conditions for continuous listing of equity shares as specified in the listing agreement with the stock exchange where the equity shares of the are listed and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements), 2015, as amended, and any circular or notification issued by the Board thereunder.
