ताजमहल की सुरक्षा पर दृष्टिपत्र पेश

नई दिल्ली, 8 फरवरी।

सुप्रीम कोर्ट ने गुरुवार को उत्तर प्रदेश सरकार को निर्देश दिया कि विश्व धरोहर ताजमहल की सुरक्षा और संरक्षण के बारे में दृष्टिपत्र पेश करे। अदालत ने साथ ही यह भी जानना चाहा कि अचानक ताज ट्रापेजियम क्षेत्र में तमाम गतिविधियां तेज कैसे हो गई हैं। न्यायमूर्ति मदन बी लोकुर और न्यायमूर्ति दीपक गुप्ता की पीठ ने राज्य सरकार की ओर से पेश अतिरिक्त महान्यायवादी तुषार मेहता से जानना चाहा कि ताज ट्रापेजियम क्षेत्र में चमड़ा उद्योग और होटल क्यों बन रहे हैं। जबकि पहले इस क्षेत्र में इस तरह की गतिविधियों पर रोक लगा दी गई थी।
